ABOUT STROLL & DASH

Now in its 24th year, Stroll & Dash is the main annual fundraiser for Sarah's Fund for Cedars. It's a lively, family-oriented, outdoor event that involves strolling and running races, all in the spirit of fun! In addition, there is kid-friendly food, a DJ, face-painting, clowns, nail art, therapeutic pets, inflatable castles, arts & crafts, and Zumba. Stroll & Dash is an opportunity to raise funds and awareness, and to also celebrate the young "superheroes" from Sarah's Floor.

The highlight of the day is always the "Superheroes & Celebrities Race," during which Sarah's Floor patients – current and former – walk or run around the track, accompanied by their family members and a local celebrity, while being cheered on by hundreds of supporters.

Since its inception, Stroll & Dash has raised nearly \$5 million dollars for Sarah's Fund for Cedars, which supports a variety of programs and services that help young patients, and their families, cope with the stress and trauma that come with a cancer diagnosis and cancer treatments. These include pet therapy, music therapy, art therapy, Dr. Clown, and H.O.P.E – the Hematology Oncology Psychotherapy Education for program for parents.

We hope that you will join us in raising money to continue providing the best care possible for our young heroes through the many excellent services and programs available on Sarah's Floor at The Montreal Children's Hospital.

INFORMATION SUR LES DONNS EN NATURE / INFORMATION GIFT-IN-KIND DONATIONS

QU'EST-CE QU'UN DON EN NATURE? PROCESSUS

Un don en nature fait référence à un bien plutôt qu'à de l'argent – plus particulièrement, à un bien en immobilisations, un bien amortissable et un bien à usage personnel. Il comprend aussi un intérêt résiduel, un droit de toute sorte, une licence, une action et un inventaire d'entreprises.

Un don en nature n'inclut pas un don en services.

Un don est un transfert volontaire de propriété pour laquelle le donateur ne reçoit aucun profit en retour. Pour qu'il y ait un don, les conditions suivantes doivent être respectées: Le donateur transfère sa propriété de biens (argent ou don en nature tels que des biens ou un terrain). Le transfert est volontaire et il n'y a pas de profit en retour pour le donateur ou pour une personne choisie par le donateur à moins que le profit ait une valeur nominale.

VALEUR D'ESTIMATION

Détermination de la juste valeur du marché (JVM)

La JVM veut dire le prix le plus élevé que la propriété pourrait rapporter, exprimée en dollars, dans un marché libre et sans restriction, entre un acheteur sérieux et un vendeur sérieux étant avertis, bien informés et prudents et qui agissent indépendamment l'un de l'autre.

Une valeur d'estimation est une évaluation de la JVM à la date de la donation. **La date de la donation est la date à laquelle le donateur transfère la propriété à la Fondation.** Le reçu émis par la Fondation doit représenter la juste valeur du cadeau au moment où il a été offert.

L'Agence du revenu du Canada (ARC) demande qu'un estimateur expert "non associé avec" le donateur ou "La Fondation du cancer des Cèdres" exécute la valeur d'estimation nécessaire si la valeur du produit dépasse 1000\$. Une deuxième évaluation pourrait être exigée. Dans ces cas, la moyenne des deux estimations sera utilisée.

Si la valeur d'un produit est inférieure à 1000\$, l'ARC a indiqué que la JVM de la propriété doit être déterminée par une personne compétente et qualifiée d'estimer le cadeau.

Veuillez noter que toutes dépenses associées à l'évaluation doivent être assumées par le donateur puisque la Fondation du cancer des Cèdres bénéficiera du cadeau.

Processus

Veuillez vous assurer que **l'information sur le Formulaire de donation soit dûment remplie.** Les reçus aux fins de l'impôt ne seront émis que lorsque toutes les exigences auront été satisfaites.

Dans le cas où un donateur ne demande pas un reçu aux fins de l'impôt, des détails sont quand même demandés pour des raisons financières et pour reconnaissance du donateur.

SVP retournez le formulaire dûment rempli au Bureau de la Fondation pour traitement. Si vous avez des questions au cours du processus, n'hésitez pas à communiquer avec le bureau de la Fondation.

The Canada Revenue Agency (CRA) requires that a knowledgeable appraiser "not associated with" the Donor or "The Cedars Cancer Foundation" perform the necessary appraisal if the value of an item is over \$1,000. A second appraisal may be requested. In such cases, an average of both appraisals will be used.

If the value of the item is under \$1,000, CRA has indicated that the FMV of property must be determined by a person competent and qualified to evaluate the gift.

Please note that any expenses associated with the appraisal, must be borne by the Donor, since The Cedars Cancer Foundation is the one benefiting from the gift.

PROCESS

Please ensure that **the information on the Donation form is completely filled in.** Tax receipts will not be issued until all requirements are met.

In the case where the donor does not wish to receive a tax receipt, details are still required for financial reasons and donor recognition. Return the completed form to the Foundation Office for processing.

WHAT IS A GIFT IN KIND?

A gift in kind refers to property other than cash – in particular, capital property, depreciable property, and personal-use property. It also includes a residual interest, a right of any kind, a license, a share, and inventory of a business.

A gift in kind does not include a gift of services.

A gift is a voluntary transfer of property for which the donor receives no benefit in return. For there to be a gift, the following conditions must be met: The donor transfers ownership of property (cash, or gifts in kind such as goods or land). The transfer is voluntary, and No benefit is provided to the donor, or a person selected by the donor, unless the benefit is of nominal value.

APPRAISALS

Determining Fair Market Value (FMV)

FMV refers to the highest price that a property would bring, expressed in dollars, in an open and unrestricted market, between a willing buyer and a willing seller who are knowledgeable, informed and prudent, and who are acting independently of each other. An appraisal is an estimate of the FMV on the date of the donation. **The date of donation is the date that the donor legally transfers ownership to the Foundation.** The receipt issued by the Foundation must represent the true value of the gift at the time it was donated.
